Budget

Juan Hernandez, Business Manager, reported K-12 Basic Education Enrollment-including ALE stood at 925.84. FTE with a fourth-month average of 925.65. In the General Fund account as of December, 33% if the fiscal year has elapsed. Revenues as of December 21st stand within expectation.

Mr. Hernandez will continue working with Mrs. Blackburn on the depreciation expenses for buildings that must be addressed in the coming years. The ending fund balance of the Transportation Vehicle Fund stands at \$316,000. Please note the school has received the new school bus.
